**ORDER GRANTING DEFENDANT'S MOTION FOR ATTORNEY'S FEES,  
COSTS, AND EXPENSES**



This matter came before the Court for hearing in Case No.: 22GS3977 and Case No.: 22GS4318 on September 12, 2022, upon the Defendant's *Motion for Attorney's Fees, Costs, and Expenses* filed in both cases. Upon consideration of the Defendant's Motion, the evidence presented to the Court, the arguments of the Parties, and the entire record, the Court FINDS and ORDERS that Defendant's *Motion for Attorney's Fees, Costs, and Expenses* shall be GRANTED for the reasons set forth therein, which are incorporated into this Order by reference. Accordingly, judgment is ENTERED in favor of the Defendant, Jennifer Tiehen, against the Plaintiffs in the amount of \$14,803.65, one-half of this amount to be assessed against each Plaintiff, pursuant to Tenn. Code Ann. § 20-17-107(a)(1). Further, for the reasons set forth in the Defendants' Motion, the Clerk shall place Attachment B to counsel's fee affidavit under seal.


